Graham Fraser was Commissioner of Official Languages between 2006 and 2016. He was previously National Affairs writer for The Toronto Star from 2000 to 2006. During his career, he has written about municipal, provincial and federal politics, and international affairs. Graham also worked for Maclean's, The Gazette and The Globe and Mail in Toronto, Montreal, Quebec City, Ottawa and Washington. He was also a guest columnist for Le Devoir from 1995 to 2000. He is the author of six books, including a biography on René Lévesque. Graham is an officer in the Order of Canada. In 1982, he was the first recipient of the Hyman Solomon Award for Public Policy Journalism. Graham was educated at the University of Toronto (Honours BA and MA in History). He has received five honorary doctorates.
